Dear Search Committee:

I am writing to apply for the position of President, Nicholls State University. I have spent my entire professional career preparing to serve as president of Nicholls State University. I have the professional preparation, education and experience necessary to lead Nicholls to the next level. As a south Louisiana native, I will be ready on day one to lead Nicholls as we take advantage of the opportunities and position the university for the challenges it will face. Nicholls is not broken. The faculty and staff are qualified and ready to work as a team to move the university forward. What is needed is a proactive leader who understands and respects the culture of the region and state. There is great potential for growth and for the university to become a strong partner with business and industry in addressing current and long term workforce development needs. The business and community references I have provided will confirm my long term involvement with business and industry groups and my commitment to having Nicholls become an active partner in meeting workforce development needs.

Most of my professional career has been spent serving in senior level administrative and faculty positions at Nicholls State University. I have always demonstrated a commitment to meeting the educational needs of individual students, many of whom have been first generation and non-traditional college students. I understand that role that Nicholls must proactively fulfill. In addition to the traditional degree programs, the President must provide the leadership necessary to position the university to be in an active partner in meeting workforce development needs of our region. This includes producing graduates needed by business and industry today and as well as those that will be needed to meet the long term economic development opportunities seven to ten years from today. To meet this challenge, the university must immediately proceed with development of an enrollment management plan. The plan must address regional, state, out of state and international enrollment growth opportunities as well as traditional degree program and alternative educational opportunities.

Budget development and implementation experience must be a strength of the next president. I have over 30 years of senior level budget experience. I am an excellent manager of resources to achieve corporate goals. I am effective at aligning resources with strategic initiatives. I understand the importance of looking at opportunities and challenges from both a short term and long term perspective. In addition to being an active participant in development of the campus budget, I have had daily budget responsibility for a \$19 million annual budget. Direct oversight of auxiliary budget units has generated over \$30 million dollars for use by the university to fund general operations. I have also served on the campus leadership team responsible for planning and oversight of over \$75 million dollars of physical plant improvement projects (residence hall, food service, student union and recreation facilities). I have a strong fiscal management record and am committed to long term fiscal stability. Experience in aligning resources with campus and program goals is a strength for me. To properly align budget resources, the university must develop compensation and physical plant plans as soon as responsibly possible to do so. The hiring and retention of high quality faculty and staff can only be realized if the university properly aligns resources with institutional goals.

In addition to budget development and oversight, I have also been actively involved with strategic planning and the SACS COC accreditation process. I have served on 8 SACSCOC accreditation teams. This experience has been valuable as our institution had to respond to severe budget cuts at a time when our region of the state was recovering from the effects of hurricanes Katrina and Rita and state budget shortfalls for most of the past 8 years.. We were able to successfully work through the challenges while maintaining focus on institutional mission and serving the economic, cultural and service needs of our region. This success was only possible because of a strong commitment to an inclusive approach to planning, management and day-to-day administration of the university.

I believe very strongly in hiring the best qualified people and providing them the resources necessary to succeed. Success occurs when the campus climate supports creativity and a sense of entrepreneurial spirit in both program development and day-to-day operations. Nicholls has a good faculty and staff in place. It is positioned to not only grow in size but in importance to the future economic development of our region. I am ready to provide the leadership necessary for Nicholls State University to achieve growth and to partner with our faculty and staff to address business and industry work force demands now and in the future.

Good institutional leadership requires active involvement in the community, including collaboration with business and industry. I have developed and maintained good relations with our business community throughout my tenure with Nicholls. Examples include serving as a three time president of the Bayou Industrial Group, a regional business and industry association serving a four parish area in south central Louisiana and serving on the board of directors for the local chamber of commerce. Evidence of a maintaining a strong and continuous relationship with business and industry leaders includes receiving the Bayou Industrial Group Big Achiever of the Year Award in 2015. I am honored to be the only higher education professional to receive this business and industry award. My involvement in the community also extends to building and maintaining a positive working relationship with local, regional and state political leaders, including our higher education coordinating and management boards.

Repairing and developing community relations must be a major focus of the next president and the entire senior administration team. Regular and clear communication of campus needs, current and long term, must be shared with community support groups such as the Nicholls Foundation. Developing a team approach with support groups regarding fundraising and other advancement activities will be critical to the university's future development and ability to meet work force development needs of our region and state. As president, I would place a high priority on the university developing an advancement plan that addresses academic program needs, physical plant issues, funding for athletics, university relations, alumni relations and the many operational and special programs offered by the university and the Foundation.

Fundraising has been a key part of my involvement throughout the region. I have served as an officer and board member for PRO-NSU, a 501(c)(3) nonprofit corporation whose purpose is to raise funds to support university activities. Other fundraising activities include serving as chairman for a local animal society group that secured over \$600,000 in public and foundation funds to construct an animal shelter and maintaining long-time involvement with the Southeast Louisiana Chapter of the American Red Cross, from which I received the 2010 Heroes Campaign Fundraiser Award. The university must invest in fundraising and other development activities. We must demonstrate to our supporters that we are serious about investing for the future.

The university has achieved success when it has planned for success. For example, beginning in 2005, the university successfully transitioned from open admissions to a selective admissions institution while maintaining its commitment to diversity and quality. The result is that the university has seen a constant upward trend in average ACT scores and retention rates, and now graduation rates. We achieved this while enrolling a more diverse student body. The implementation of a well thought out plan enabled the university to exceed enrollment expectations projected by higher education leaders in 2005. It is time for the university to develop a new enrollment management plan.

Our success has been recognized by The Education Trust in a report released March 23, 2016 titled "Rising Tide II: Do Black Students Benefit as Grad Rates Increase?" Our institution was recognized as one of 52 institutions that stood out for substantially improving graduation rates while also achieving gains for black students. This occurred because we maintained a strong commitment to individual student success. Students vote with their feet. If students find a supportive, student centered campus community; they will remain enrolled and succeed. If the university does not demonstrate a consistent commitment to student success, students will vote with their feet and leave.

Continuous improvement of the university based on planning grounded in a clear vision and assessment results is necessary to support a culture of continuous institutional improvement. Our campus experienced such a campus transition, moving from a paper driven administrative services campus to a student centered personalized electronic operation that focuses on what each student needs from the university to succeed. I was selected by one of our former president to lead the campus through this transition because of my ability to work with all campus constituencies.


We have also made significant improvement to the facilities that provide a quality student life experience. New and renovated residence halls, a renovated and continuously updated food services facilities program, an updated student union, and the opening of a campus recreation center have changed campus life. Students have responded to these improvements by rating their experience at Nicholls among the top Louisiana institutions in student satisfaction as reported on the ACT Student Satisfaction Survey. Many of our services and programs have moved from worst to first in our system ratings over the past sixteen years, exceeding national averages for most categories (NSSE and ACT Survey results).

Throughout my career, my work has been recognized by administrative and faculty rank promotions. This occurred because I have maintained high professional standards that are reflective of best practices. I have been promoted from the administrative position of director, to dean to vice president while attaining faculty rank promotions from instructor to assistant professor to tenured associate professor. This is the result of a strong commitment to the academy. I have maintained active faculty involvement throughout my career in higher education. Examples include teaching undergraduate and graduate courses and serving as the coordinator for the masters in educational leadership, concentration in higher education program at Nicholls State University for the past 19 plus years. Attaining graduate faculty rank and serving as major professor for over 100 graduate students required a sustained significant commitment to the academy.

I have spent my professional career demonstrating commitment to ideals advocated by the Mission Statement of Nicholls State University. The references that I have provided will confirm my long-term commitment to academic excellence, service to students, sound fiscal management, diversity, an inclusive and transparent approach to campus governance, and active involvement in the community (business, industry, governmental and k-12 education). I am recognized as a change agent who can actively multi-task, stay focused on institutional and individual student needs while working with various constituencies to achieve success.

I have served as a vice president for three presidents of Nicholls State University. My Ph.D. is in higher education . I have spent my entire career preparing to be president of Nicholls State University. I am ready to hit the ground running to address internal and external opportunities and challenges. If I am so honored as to be selected to serve as the next president of Nicholls State University, I commit to stay until Nicholls achieves its long term goals.
